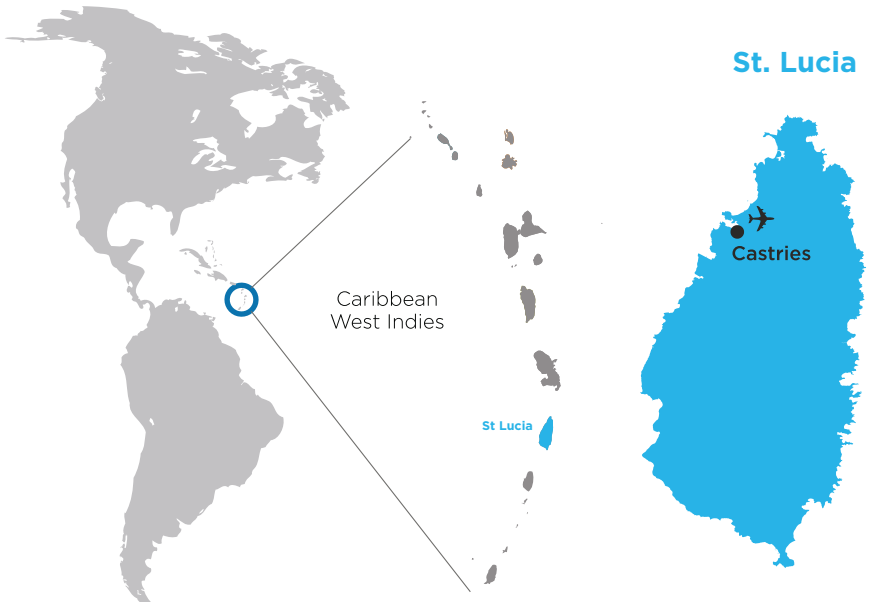

# CITIZENSHIP BY INVESTMENT PROGRAMME

Located south of Antigua and northwest of Barbados, Saint Lucia is a sovereign island country in the eastern Caribbean Sea and the Atlantic Ocean. The volcanic island is part of the Lesser Antilles and is the most developed of the Windward Islands. It is breathtakingly beautiful; dominated by twin peaks known as the Pitons that soar over 2,500 ft high. An idyllic tropical paradise, St. Lucia is an incredibly popular vacation destination. The island offers excellent views, spectacular scenery, phenomenal beaches, and plenty of sunshine.

St. Lucia provides the perfect backdrop for adventure or relaxation. Take a stroll through the rainforest, refresh yourself under the exhilarating waterfall, or take a laid back boat tour. For the more adventurous adrenaline-seekers, ride horseback along the coast, climb the Pitons, scuba dive, snorkel, or kayak in the most amazing turquoise waters. Your adventure awaits.

The Official Government Programme passed under the St. Lucia Citizenship by Investment Act No.14 in 2015, which allows high-net worth individuals to apply for citizenship of St. Lucia upon making a qualifying investment in the island. Although it is the newest Citizenship by Investment Programme in the Caribbean, it has proven to be advantageous, gaining decades of experience from neighbouring sister programs.

Its programme is efficient and cost-effective, making it an easy choice for investors seeking mobility, including access to visa-free travel, economic stability, and better quality of life.

## ADVANTAGES OF ST. LUCIA CITIZENSHIP

- No requirements to travel to Saint Lucia during the application process;
- No taxes for non-residents;
- No physical residency requirements;
- Saint Lucia recognises dual citizenship so you can retain your current nationality;
- Any unmarried siblings of the Main Applicant, below 18 years of age who has received the consent their parent or guardian to make an application for citizenship by investment;
- Saint Lucia is a member of the Commonwealth, which entitles citizens to certain privileges in the United Kingdom and other Commonwealth countries;
- Saint Lucia is an attractive place to live and own a second home, with excellent air/travel connections to North America, Canada and Europe;

# VISA-FREE TRAVEL

St. Lucia's Citizenship by Investment Programme is central to the concept of global citizenship. A Saint Lucian passport provides visa-free travel to **more than 135 countries**, including the **Schengen States (EU)**, **United Kingdom**, **Hong Kong**, **Canada\*\*** and **Singapore**.

(i) if the applicant made an application for citizenship by investment including a qualifying dependant who is a child less than eighteen years of age; and

ii) if the qualifying dependant submits to the Board a letter of acceptance from an educational institution that is established or to be established within the approved real estate project.

The CIP launched the National Action Bond (NAB) as a new non-interest-bearing Government bond - to replace the Special COVID-19 Relief Bond. It's also an available investment option under the Saint Lucia CBI Programme. Applicants and qualified citizens must hold the bonds for a minimum of 5 years and then they can recoup their initial investments. This makes this option one of a kind among all the others.

\* The bonds are non-interest bearing, and must be registered and remain in the name of the applicant for a five-year holding period from the date of first issue.

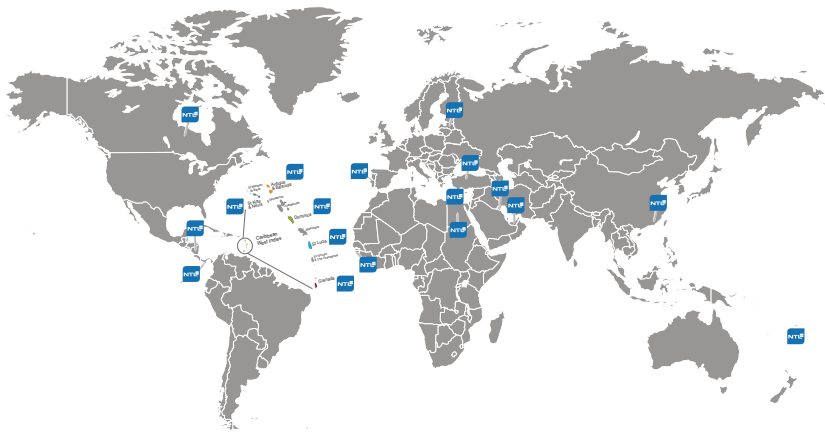
