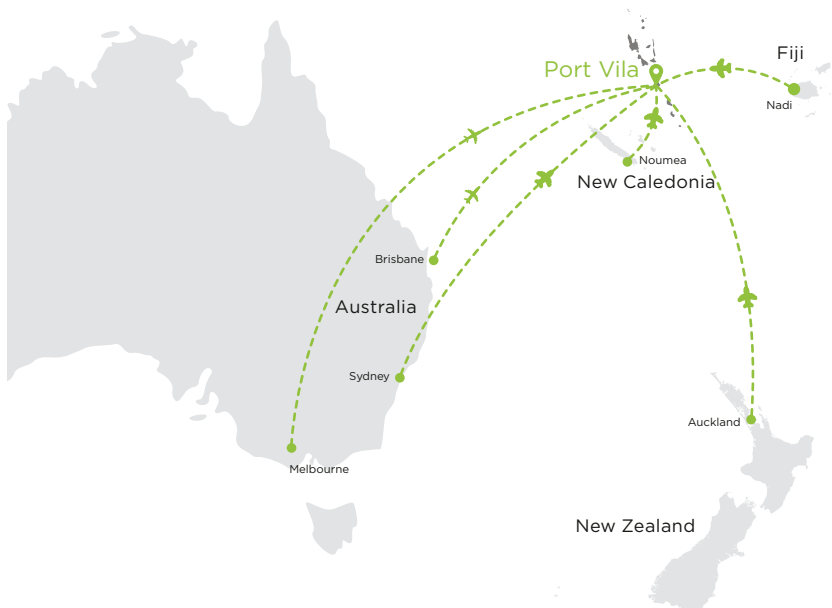

WHY VANUATU SECOND CITIZENSHIP?

DSP REQUIREMENTS

- Applicants must be over the age of 18 and below 65 when submitting their application.
- Applicants should have no less than US\$ 250,000 of net personal assets when submitting their application.
- At the start of the application, the applicant must deposit US\$ 10,000.
- When the application has been approved by the Financial Intelligence Unit (FIU), the applicant must deposit the remaining fee.



REQUIRED DOCUMENTS

LIST OF DOCUMENTS REQUIRED TO SUBMIT AN APPLICATION

1. Application forms (for main applicant, spouse, children, parents).
2. Existing passport notarized color scan: must show the page in its entirety, passport cover + 1st 3 pages of the passport + last 3 pages of the passport = 7 pages in total (for main applicant, spouse, children, parents).
3. ID card notarized color scan, front and back, photocopied on 1 page (for main applicant, spouse, children, parents).
4. Proof of relationship between main applicant and his / her spouse, children, parents notarized (marriage certificate, birth certificate etc.).
5. Most recent proof of dependency of children (e.g. education) and parents (same address, monthly payments etc.).
6. Birth certificate of all applicants notarized.
7. Original certificate plus notarized copy of criminal record with apostille from the jurisdiction in which he / she has resided during the last 12 months and (if different) the jurisdiction of his / her principal nationality (for main applicant and dependents aged 18 and above).
8. Most recent academic certificates or reports (for main applicant, spouse, children, parents).
9. Medical Checkup Certificate for applicants aged 18 and above from the state of origin or place of residence.
10. Asset Proof of no less than US\$ 250,000, and bank statement of past 6 months.
11. Main applicant's CV and if applicable proof of employment from his / her company.
12. 6 passport photos, 40 mm × 50 mm (for main applicant, spouse, children, parents).

NOTE:

(i) Color copied. All documents need to be in English.
Translated documents need to be notarized too where applicable.

(ii) All submitted photocopied documents (main applicant, spouse, children, parents) need to be signed by the main applicant before scan and transmission to us.

CITIZENSHIP APPLICATION PROCESS

THE GREEN LABELS SHOWS THE IDEAL OR TARGET TIMING OF EACH STEP.

STEP 1	Applicant sends passport copies and copy of translated police record(s), plus wires initial deposit of US\$ 10,000.	1-2 Weeks
STEP 2	FIU undertakes initial KYC checks, possibly requesting additional information in case of doubts.	2-3 Weeks
STEP 3	FIU issues Clearance Certificate.	2-4 Days
STEP 4	Applicant pays the remaining application fee and sends complete application with all supporting documents to Vanuatu.	3-6 Weeks
STEP 5	Application is submitted to Citizenship Commission for analysis.	1 Week
STEP 6	Citizenship Commission may ask for cure of provided documents and for additional documentation. If all fine. The application is approved by Council.	2 x per Month
STEP 7	Citizenship Commission issues Citizenship Certificate signed by the Prime Minister of Vanuatu.	1 Week
STEP 8	Applicant's (above 18 years) take Oath of Allegiance either in Vanuatu or in a place of convenience and then receive Citizenship Certificate(s) and Passport(s)	2-6 Weeks

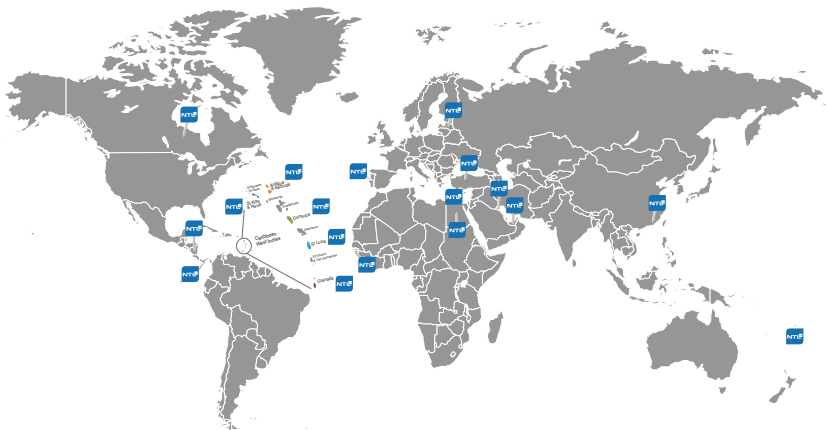
